## **Conditions of Entry**

- These Conditions of Entry incorporate and must be read together with the accompanying Schedule for this Promotion. <u>The accompanying</u> <u>Schedule prevails in the event of any inconsistency with these Conditions of Entry, to the extent permitted by law</u>. By participating in this Promotion, each participant fully and unconditionally agrees and acknowledges that these Conditions of Entry are binding.
- 2. Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, except where stated otherwise.

#### Eligibility

- 3. To enter the Promotion, the Eligible Entrant must complete the Entry Procedure during the Promotion Period.
- 4. Entry to the promotion is available to new and existing customers, including employees of Westpac Banking Corporation or related entities, who meet the entry restrictions and continue to meet the entry restrictions at the time of awarding the prize. Members of AUSIEX (including AUSIEX employee's immediate families) are not permitted to enter. Individuals whose account, at any time in the Promotion Period, is locked for a reason that may involve legal actions will not be eligible to participate in the Promotion.
- 5. The Promotion will be conducted during the Promotion Period.
- 6. Subject to clause 9, entries are automatic in accordance with the Entry Procedure and will not be accepted by the Promoter in any other form.
- 7. Eligible Entrants may enter the Promotion up to the Maximum Number of Entries.
- 8. Entries must be received by the Promoter during the Promotion Period. Online and phone entries are deemed to have been received at the time of receipt into the Promotion database and not at the time of transmission by the Eligible Entrant.

## **Determining and notifying Winners**

- 10. The Prize draw(s) will be conducted in accordance with the Draw Details. The Prize(s) will be awarded to the Eligible Entry or Entries (as applicable) randomly drawn in accordance with the Prize Details. The Promoter may draw additional reserve entries and record them in order, in case an invalid entry or ineligible entrant is drawn.
